Hurricane Florence in September, but none were hit as hard as the North Carolina coast and the SC Pee Dee region. Both of which are in the beginning stages of recovery. One factor about flooding that many in the public seem to forget, is that the largest and most voracious mosquito species are produced by floodwaters. The good news is that these species rarely transmit disease, but the rate that these species emerge can make cleanup and recovery and nightmare. Those who are familiar with the bite of one Psorophora ciliata will know that being outside among thousands of them will be an impossibility. Relief cannot come soon enough for those affected by the flooding.

The 2018 SCMCA Annual Meeting is very near and I hope to see everyone in Greenville, November 7-9, 2018. We have some great presentations planned as always and a beautiful venue to view them in. If you haven't registered already, make sure you do soon. 

Mosquito Control Program Updates

Upper Region

City of Greenwood

Billy Allen with the City of Greenwood stated that there has been no increase in the number of mosquitoes this summer. Therefore, the number of complaints had not increased this summer. He did mention that there was a confirmed case of West Nile, so they have been busier this summer. Mr. Allen has also implemented a program, that when a call comes in, the City of Greenwood likes to respond with a visit to the property to not only look for potential breeding habitats, but to also help educate the property owner on ways to reduce mosquito populations around the property. Mr. Allen also mentioned how they like to give homeowners an educational refrigerator magnet that has mosquito tips and a number to call for mosquito complaints. The City of Greenwood has a new truck mounted sprayer that uses GPS to track where they spray, and they also have a new backpack sprayer. Mr. Allen stated that they acquired BG Sentinel II traps through a grant and hope to start trapping in the next few weeks. Mr. Allen commented that one person from their organization will be attending SCMCA Annual Meeting in Greenville later this year.

City of Fountain Inn

Lori Cooper with the City of Fountain Inn stated there has been an increase in the number of mosquitoes in certain areas, as well as an increase in rain and standing water this summer. Due to this increase of rain and standing water, they have added information to their website about removing standing water. Ms. Cooper said that they will continue to spray in October with Biomist.

Upper Region continued

City of Edgefield

There are no new reports or developments per David Coleman with the City of Edgefield. Mr. Coleman stated that there has been no increase in mosquito activity or complaints for this summer. He said that the City of Edgefield will stop spraying for mosquitoes in October. During the winter, they plan to start prepping for the 2019 season by testing and calibrating their spray machine. Mr. Coleman also mentioned that he hopes to attend the SCMCA Annual Meeting in November this year.

City of Gaffney

Barry Bundy with the City of Gaffney has reported there has not been an increase in mosquitoes or complaints this summer. The City of Gaffney has a new truck mount sprayer, back pack sprayer, and employee in Mosquito Control. Mr. Bundy mentioned they have had a problem with standing water at vacant houses with pools, but they hope to be able to drain these pools soon. Mr. Bundy also said he will be attending the SCMCA Annual Meeting this year.

Middle Region

City of Columbia, SC

We've done some larvaciding and spraying (with our very new equipment, thanks DHEC). Stacy Harris and Antione Williams have taken the lead in larvaciding and spraying, while Rick Blackmon has taken the lead on news interviews and press releases. We have been encouraging citizens to report dead birds and have turned in several to DHEC in the last few weeks.



Richland County, SC

This has not been a typical summer for us. At one point we thought it seemed quieter than usual, however, when someone commented on that - we had to tell them don't jinx us! The last time we felt that way was 2015, and we had spoken too soon! That is sort of how we're viewing things now as Hurricane Florence works its way towards us... things are about to get hot and heavy. The low mosquito numbers and light rainfall are over.

We had our annual Pesticide, Herbicide, Fertilizer inspection last month – everything was fine as usual. We are still in the process of hiring someone for filling Rachel's vacancy. The interviews were completed weeks ago, but it just West Nile activity in the county, but nothing like we had last year.

At this point, we're hoping to pass through the storm without issue, and looking forward to colder temperatures and hope to be at the annual meeting in Greenville. Hope to see you there!

Mosquito Control Program Updates

Lower Region

Beaufort County Mosquito Control Program

Mosquito season in Beaufort County started relatively late this year, as I'm sure it did in most parts of the state. May and June showed a 40% decrease in complaints compared to 2017. The season ramped up in July and August with an average complaint increase of 180% over 2017. September has been slow so far compared to 2016 and 2017 when we had an average of 415 complaints. Over 90% of which were received in the last half of the month following Hurricanes Matthew (2016) and Irma (2017). Beaufort County thankfully had no issues stemming from Hurricane Florence.

Aerial adulticiding and larvidicing missions got off to a slow start due to aircraft malfunctions, but are now operational and continue to be a crucial asset in controlling mosquitoes around the county. Mosquito control personnel are currently retreating problematic catch basins to ensure our West Nile virus (WNV) incidence remains low.

Mosquito collections on average have been similar to previous years with no unusual increases or decreases. Beaufort County uses a variety of mosquito traps for both population and disease surveillance. There have been no reported, locally acquired mosquito-borne disease cases in Beaufort County so far in 2018 and no mosquitoes, birds, or horses have tested positive for any mosquito-borne disease.

So far in 2018, BCMC has two new employees, a field technician to fill a new position, and a new manager/biologist to replace a legend who retired after more than 30 years. There are no other program changes to report at this time.





































Obtaining a Non-Commercial License for Mosquito Control

In order to obtain a Category 8 Public Health Pest Control License, you must obtain training materials prior to taking the exam. No classroom instruction is provided.



The two manuals needed are: (1) Core Manual – Applying Pesticides Correctly (PTS CORE), \$25; and (2) Category 8 – Public Health Pest Control (PTS8-SR18), \$15. Order the manuals online at https://clemson.edu/dpr, click "Exam Information" on the right, then under "Exam Information for SC Applicator's License" click, "Order Exam Study Materials Online." These manuals can also be ordered by phone from the Clemson University Bulletin Room: (864) 656-3261 or (888) 772-2665. The



exam fee for the Core + Category 8 is \$100. Each additional category is \$50. Before taking the exam, you must preregister with the Clemson University Department of Pesticide Regulation (864-646-2150). Specifically, you should contact Holly Lizotte (Phone: 864-646-2164; E-mail: hlizott@clemson.edu) to pre-register. You must provide your name, address, phone number, social security number, and the name of the exam (Category 8). You will be given an

Identification Number. The exam location, date, and time will be set up during the pre-registration process. Directions to the testing center will be provided.

The exam is taken on a computer, and it is offered at testing centers around the state. The exam will cover the core principles of pesticide labels, environmental factors, pest and pesticide knowledge, pesticide laws, pesticide equipment and application techniques, and safe pesticide use, as well as knowledge specific to Public Health Pest Control. The results are known immediately upon completion of the exam.

Santee Cooper's Secret Agent

I will never forget the day I discovered my father's true profession.

Growing up as a child who loved the game of baseball, my father and I would often play catch in the front yard. Sometimes he would be the catcher as I practiced pitching and sometimes he would roll me ground balls and throw me pop flies.

One day during the middle of one of our workouts, he randomly stopped what he was doing and looked down one of his legs. He then gently yet promptly raised his glove hand just before slamming it hard against his leg. "Got 'em!" he yelled as he pealed the now flattened mosquito carcass from his 1995 Rawlings Paul O'Neill Edition glove.



"Ahh, Aedes Albopictus," he said, examining the pest inches away from his eyes. He then looked at me and said, "This here is one of the most common mosquitos in the area and they primarily bite people around the ankle and calf area."

The information was interesting and would stick with me for years to come, but what I witnessed shortly after playing catch on that hot summer day would be embedded in my head for a lifetime.

I had just finished washing up for supper when I looked outside of a window and noticed white smoke forming outside where we had just played catch. The smoke was so thick and so dense it looked like my house had risen hundreds of feet and wound up lost in the midst of a cumulonimbus cloud.

I rushed outside just as the sound of a motor abruptly stopped. The milk-white smoke began to settle and a silhouette appeared from a distance. The silhouette slowly revealed itself to be my father who was holding a flame-throwing, ghost busting, life-threatening, alien-slaying, gun-like object with a flame still lit at the end. "Adios Aedes Albopictus," he said in an accomplished tone. My eyes, the size of half dollars, stared at him and my heart filled with a rare mixture of amazement and utter terror as the epiphany set in. My father was a trained mosquito assassin!

I recently had the opportunity to shadow my father, John Grant, and the Vector Management crew (a.k.a. the mosquito assassins) at Santee Cooper. Species Spotlight:


Newly Discovered Species!!

Ae. hagerii

This mosquito is easily identified by the abdominal bands that resemble the letter "H". This is the most elusive mosquito of all! Its range is typically in the Beaufort, Charleston, & Hampton areas, however, they have been found in Colorado, Texas, and have even recently been sighted in Kentucky. They are also frequently found in the Appalachian Mountains. They don't feed much but are typically found near horses, dogs & cats.







Species Spotlight:

Newly Discovered Species #2!!

Ae. carydensis

Note the unmistakable "C" pattern on the thorax that makes this mosquito easy to identify. This mosquito is unusual because it is a social insect, and instead of feeding on blood it prefers beer or Scotch. This is the only mosquito appreciated by the armed forces.
