

Lower Region Representative

Julie Davis

Upper Region Representative

Born and raised in the upstate of South Carolina, Julie Marie Corley Davis is originally from Powdersville, SC. After graduating from Clemson University with a Bachelor of Science in Resource Management and a Minor in Wildlife, Aquaculture, and Fisheries Biology, Julie began her professional career with the SC State Park Service. After working with them for six years, she went back to Clemson and obtained her Master's degree in Parks and Protected Area Management.

After graduation, Julie was hired on with Greenwood County as Lake Manager in 2006. Lake Greenwood, situated in the foothills of SC is an 11,400 acre lake owned by Greenwood County and bordered by three counties. Lake Greenwood, a FERC licensed project, was created in the late 1930s, and is a treasure for the surrounding communities. Lake Management staff perform mosquito control with larvicide treatments on Lake Greenwood.



Upper Region

City of Fountain Inn

The City didn't perform mosquito activities last year because of COVID. For this year, they are planning to respond to citizens and usually do residential treatments according to complaints received.

City of Gaffney

The City usually starts in March or April, depending upon the weather conditions. They usually do adulticide spray treatments once a month. This year will probably be along same lines as last year's program.

City of Seneca

The City usually conducts mosquito control every 2 weeks, as need. The city employees perform the mosquito treatments, and will probably start in May, but it will be dependent upon the weather.

Middle Region

Richland County

First and foremost, Richland County would like to extend our thanks and congratulations to Tammy Brewer who retired on December 31, 2021 after almost 32 years of dedicated service. Our program will not be the same without her expertise, but we hope to continue the legacy that she helped build. Following Tammy's departure, Olin Towery took over as the Manager of Vector Control, and Chelsey Reed moved into the Supervisor of Vector Control position. We are currently facing staffing shortages, but have submitted paperwork to hire two more full-time team members who should start in March.

We are also in the process of hiring two part-time, seasonal team members. Beverly Whitmire was awarded a fellowship grant to attend the virtual DODD Short Courses this past January, and she was gracious enough to take over as SCMCA's new Secretary-Treasurer. We plan to begin West Nile Virus surveillance trapping in March in collaboration with SCDHEC, and our light trap routes should start in April. Between the position changes, the many training opportunities, and interviewing to hire new staff, we have managed to stay very busy in our offseason and expect that to extend well into the hot summer months!

Olin Towery Richland County Vector Manager

Lexington County

Lexington County Vector Control experienced less than 50 mosquito complaints from citizens last season! Most of those calls were referencing *Aedes albopictus*, so they have focused on educating the public about how they can eliminate mosquito breeding at home. John Matthews started last April and has learned the job very quickly to become an integral part of the team. They are keeping tabs on ditches and picking up tires within the county to reduce breeding sources, and expect to adulticide this season as needed.

Middle Region

Sumter County

Sumter County is gearing up for the 2022 season. They are getting the trucks ready and are in the process of hiring and training new drivers since they lost some experienced techs from last season to retirement. Here's to hoping for a mild season with no tropical storms! 2021 was a pretty good year as they processed only 63 requests for the entire year.

Alan Penland

Lower Region

Berkeley County

"While we did have our normal floodwater mosquito hatch-offs in September here in Berkeley County, I would say that they were relatively small compared to those we experience most years. Actually, 2021 was probably one of the mildest years for mosquitoes that we've experienced in the last ten years. We received markedly fewer service requests from the public all year. This was especially noticeable in the fall months, when we're used to having a surge of incoming calls and emails. We did see a couple more arboviral cases in the county than we usually have, but we were able to carry out the recommended response procedures with no issues. We are currently in the process of updating our spray zones to accommodate Berkeley County's rapid expansion of residential areas into what was previously undeveloped forest. Otherwise, our department has not undergone any significant changes recently. We hope that the mosquitoes of the 2022 season do not try to make up for the relative quiet of 2021 with a population boom."

Andrew Starland

Beaufort County

Overall, we had an average mosquito season in 2021. We had a very late WNV+ American Crow that was detected at the beginning of December. We were able to continue trapping into January, but found no WNV+ mosquitoes.



We added a new laboratory technician

position back in October and one of our previous lab interns was hired into that role. He recently attended the Dodd Identification of Adult Mosquitoes course in Gainesville, FL. We also recently filled one of our vacant field technician positions. We still have two open field crew positions that need to be filled.

We are in the process of annual maintenance on our aircraft and we hope to have both ready by the end of February. In April, we'll start our yearly process of treating the catchbasins with larvicide briquettes.

Lower Region

Charleston County

As the overall larval and adult mosquito activity level began to wane significantly in November 2021, the Charleston County Mosquito Control Program's (CCMCP) endeavors shifted to equipment maintenance and staffing efforts. New hires included Andrew Pierson, Entomologist, Daniel Budd, Field Inspector, and Matthew Middleton, Spray Technician. Promotions included Jon Loveland, to Assistant Manager, and Robert Bonfoey, to Field Inspector. Maintenance projects completed in late 2021 and January 2022 included the overhaul of eight Guardian ULV sprayers, and the overhaul of thirty-five New Jersey Light Traps, one hydraulic pallet jack, and the Big John agricultural Mist Blower high volume sprayer. Also completed was the removal, overhaul, and re-installation of the engine in one of our two MD-500 helicopters, N991MC. Meetings continued between CCMCP's Manager, Assistant Manager, Charleston County Public Works (CCPW) officials, and architects and engineering construction contractors concerning the proposed new CCPW facility building complex.

City of Myrtle Beach

The City of Myrtle Beach Mosquito Control Program will maintain the same level of service as last year. We plan to change the adulticide that we are currently using about mid-season. The city is still growing fast and we are moving fast to provide service to these new neighborhoods. No other changes to the program are planned for this year.

Lower Region

Horry County

Horry County checking in here. As 2021 is behind us with it being one of our slower and driest seasons; On the other hand, the beginning of 2022 isn't looking to promising with the winter temperatures up and down. One day there's snow and ice and the next there is 68 degree weather. We are looking at bringing in three additional part time employees to help with surveillance and larviciding. We are looking into also purchasing a drone to help with larviciding and adulticiding along with enhancing our mobile adulticiding fleet to a number of eight trucks with ULV sprayers. We will be adding an additional UTV with a thermal fogger to help spray county parks and athletic fields. We will also be using an A1 Mister



in the UTV for liquid larviciding roadside ditches and swampy areas.

From dealing with extreme cases of Covid-19 to product supply problems, the light at the end of the tunnel looks dim at the present time.
