# Possible Dissolution of the Santee Cooper Vector Management Program

The South Carolina Mosquito Control Association was made aware of the potential dissolution of Santee Cooper's Vector Management program (SCVM) at the SCMCA Annual Meeting in November 2024. SCVM has supported the South Carolina Mosquito Control Association in numerous ways over the years, most notably by graciously allowing the SCMCA to utilize its Wampee Conference Center in Pinopolis, SC for the Summer Workshop every year at no charge.

Despite Santee Cooper Vector Management having been responsible for conducting mosquito abatement activities along the boundaries of Lake Marion and Lake Moultrie since 1934, a renewed Federal Energy Regulatory Commission (FERC) license that lacks an explicit mosquito control requirement has prompted Santee Cooper to eliminate the Vector Management program.

Lakes Marion and Moultrie are surrounded by numerous residential subdivisions and are popular recreation areas for thousands of South Carolinians. This service territory includes area in Berkeley, Calhoun, Clarendon, Orangeburg, and Sumter counties, all of which rely upon Santee Cooper Vector Management's efforts to preserve the habitability of communities on the Lakes and protect the public health of the Lakes' residents and visitors.

In a best-case scenario, dissolving SCVM shifts the burdens of responsibility and expense for conducting mosquito abatement activities to the taxpayers of the Lakes' five surrounding counties. In a worst-case scenario, eliminating the Vector Management program eliminates mosquito abatement activities in its service area. Although most recreators may be most concerned with mosquitoes as a nuisance, SCVM's mosquito control activities include arbovirus surveillance, the lack of which will leave these communities more vulnerable to mosquito-borne illnesses such as Eastern Equine Encephalitis and West Nile Virus.

The value Santee Cooper Vector Management provides to these communities cannot be overstated and the potential harm that ensues from dissolving the program would be incalculable.

The SCMCA stands firmly in support of Santee Cooper Vector Management in urging Santee Cooper leadership to reconsider this disastrous decision. If you are a concerned vector control professional, a resident of the Lakes or affected counties, a Santee Cooper ratepayer, or someone who simply enjoys recreating at Lake Marion or Lake Moultrie, we urge you to write to Santee Cooper executive leadership and express your concern. 


#### Vice President - Andrew Pierson

# Middle Region Updates

# Chesterfield County

A new sprayer was purchased with the hurricane funding grant and will be installed this spring, upgrading from the Clark Cougar sprayer to the Grizzly. A backpack sprayer was also acquired for fogging and for use in parks and areas inaccessible by the truck. The department remains under Jaime's leadership, with an individual working under his license. No complaints have been reported so far. Due to proximity to the Pee Dee area, larviciding will begin in late March.

# Darlington County

No major updates currently, possibly hoping to bring on some new people for trapping and spraying. three new hires in the department, hoping to have some of these improve on the mosquito control program. Also hoping to use the hurricane relief funding to bolster the program. As of January a new public works director has been appointed.

# Florence County

Florence County is using the funding from the hurricane recovery grant they purchased two new spraying units and upgraded their software package (GIS data) to better track spraying locations and complaints.

#### Marlboro County

Marlboro County used hurricane recovery funding to buy a new sprayer and more product. They are hoping to keep up with mosquito requests this year, as they started late last year. They are also seeking to get certification for mosquito spraying for the public works director and part time staff.

# Newberry County

Business as usual; there are no new employees, preparation, or adverse to report in an uneventful off-season.

#### **Richland** County

Richland County has stayed busy in the off season with equipment maintenance and trap repair. They are now in the process of hiring two new full-time employees who will start in March, just in time for catch basin treatments! With the hurricane funding, two new ATVs have been purchased and everyone is very excited to put them to use. Chelsey Reed will be attending the AMCA Annual Meeting in San Juan, Puerto Rico in March. Otherwise, they are preparing for a busy season ahead of trapping, treating, and training!

# Orangeburg County

Gregory Pest Control is no longer on contract, and Orangeburg is putting out a Request for Proposals and hoping to award a contract quickly.

#### Sumter County

Getting ready for the upcoming season. No new employees, but the same guys are coming back this year to do the spraying. Basic prep during the off season – maintaining equipment and communicating with employees and communities to respond to complaints.

# Lower Region Updates

# Charleston County

CCMC has spent the winter performing equipment maintenance and plotting a course for spring. Among other projects, CCMC has begun mapping storm drains in FieldSeeker to implement a more comprehensive treatment program. The new Public Works complex nears completion, with an anticipated move-in date sometime between June and August. Mosquito Control in particular is poised to receive vastly improved facilities, including a new lab and a dry ice pelletizer that was purchased with the first round of hurricane recovery funding.

# City of North Myrtle Beach

The City of North Myrtle Beach has been hard at work this winter preparing for the upcoming year. As spring approaches, we have completed the treatment of our stormwater system with larvicide and are now focusing on wetlands and retention ponds. This year, we plan to purchase four new ULV machines.

We've had a cooler winter with slightly less rainfall than usual, which we hope will result in fewer mosquito complaints this summer. We look forward to seeing everyone at the Summer Workshop later this season.

# Horry County

Hi Everyone ,

I hope everyone had a good holiday season!! Now unfortunately it's time to go back to the grind. We have had a really dry winter, as you can tell by our wildfire problem. Fortunately we have not lost any homes or businesses as I'm writing this. A big Thanks to all of the first responders throughout the county and state!! We are still waiting on our new building to be completed hopefully we will be in it by the end of June. We have just finished our first round of larviciding for the year and have gotten all of the spray trucks ready for action as well as out traps. Also we'll be purchasing at least 4 more ULV sprayers this year to add to the fleet. We just hired another Mosquito Tech (Raymond Usher) and will be adding a couple more by late spring we have also added an administrative assistant (Crystal Mew), as the county counties to grow so do we. In the off season everyone got their licenses as well as spill training. Hopefully we won't have any major storms this year!! Look forward to seeing everyone at the summer workshop, Stay Safe!!
